



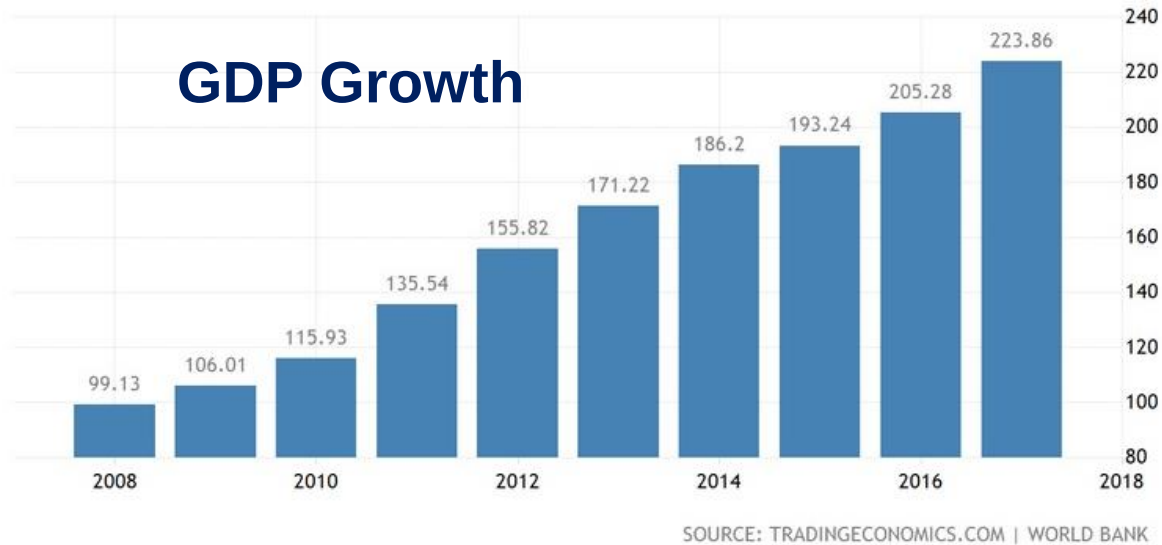

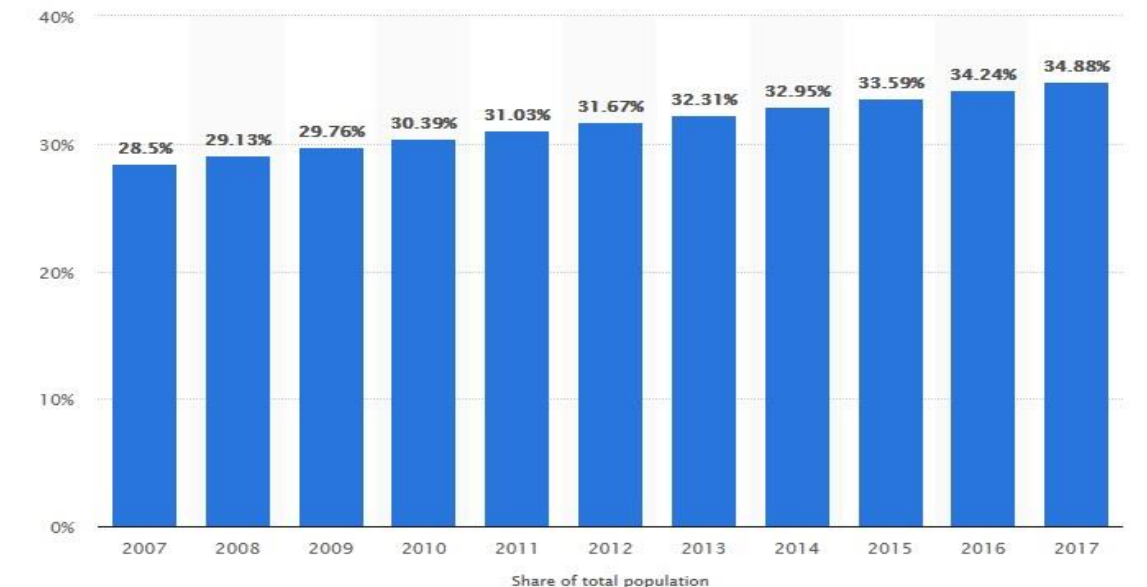

What is missing?

Policy: National energy efficiency standards for EE Codes Enforcement are to be consolidated and strengthen enforcement

➤ **Weak NDC climate targets:**
136 NDCs mention the building sector,
but lack concrete actions and targets



- **Knowledge:** expertise and knowledge for cost effective technologies penetration into the market; EE certification for buildings
- **Financing:** Investment cost vs. operation cost and lack of financial instruments

Vietnam – starting NDC implementation in the building sector

Building sector

- Fast-growing with **30% of total energy consumption**, mainly in **residential and commercial buildings**

NDC commitments

- **Until 2030** reduce GHG emissions by **11.84 Mio tCO₂e (8%)** and unconditionally by **37.83 Mio tCO₂e (25.7%)**
- **Vision for 2031 to 2050** to achieve **zero emissions from the construction industry by 2050**

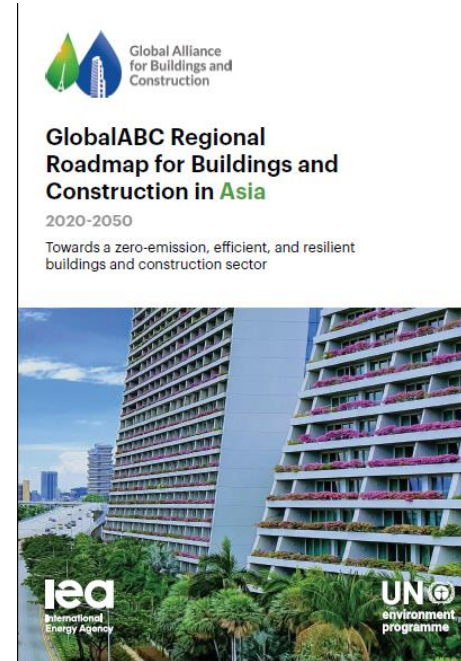
NDC Roadmap approach

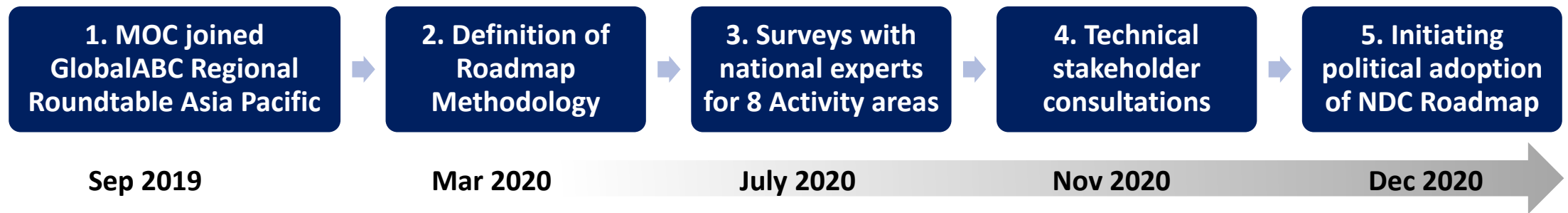

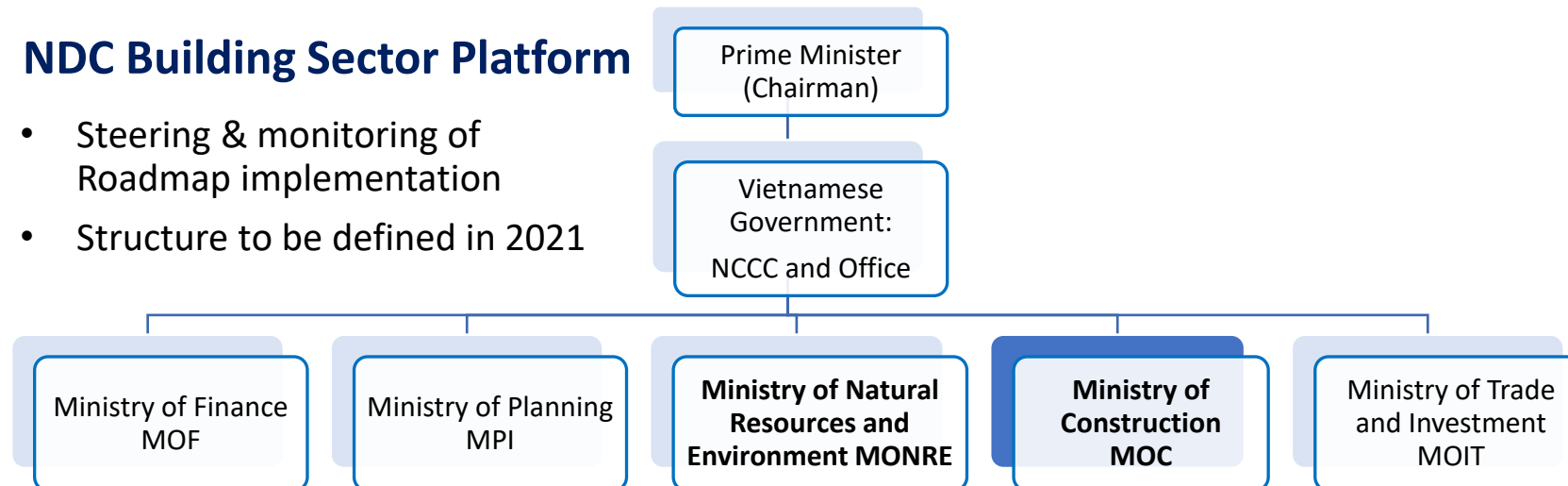
